## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do the experiment in Question 1 and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

### Question 1

Each candidate should be provided with:

	knife or scalpel	1
	empty 250 cm <sup>3</sup> beaker labelled <b>water-bath</b>	1
	a supply of warm tap water at 40 °C Candidates will raise their hand when they require warm water.	100 cm <sup>3</sup>
	stop-clock	1
	paper towels	5
	gloves	1 pair
	suitable eye protection	1
	30 cm ruler with mm scale (also needed for Question 2)	1
	10 cm × 10 cm piece of white card	1

**Preparation of materials***2% agar containing universal indicator*

This should be prepared the day before the exam and stored in a refrigerator overnight.

Sprinkle 20 g non-nutrient agar onto 1 dm<sup>3</sup> distilled water in a beaker. Boil the mixture and stir continuously until it clears. Remove from the heat and add 10 cm<sup>3</sup> universal indicator **[F]** to obtain a green colour. If the agar is a red or orange colour after adding the universal indicator, add drops of 1 mol dm<sup>-3</sup> sodium hydroxide **[C]** until the agar turns green or blue-green. Pour the molten agar into shallow trays to a depth of 1 cm.

When the agar has set cut it into blocks which measure at least 1 cm × 2 cm × 2 cm. Each block should be presented to candidates on a white tile.
