## General information about practical exams

Centres must follow the guidance on science practical exams given in the *Cambridge Handbook*.

### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Only those procedures described in the question paper should be attempted.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### During the exam

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor **must** perform the experiments and record the results as instructed. This must be done **out of sight** of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the bar code label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number
  - the attendance register.

## Specific information for this practical exam

During the exam, the supervisor (**not** the invigilator) must do all the experiments and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.  
If chemicals are prepared in more than one batch, clearly labelled supervisor's results must be provided for each batch. The candidates using each batch must be listed on the supervisor's report.

<b>FA 1 [MH]</b>	5.0 g	hydrated ammonium iron(II) sulfate	Provide 4.8–5.2 g of $(\text{NH}_4)_2\text{Fe}(\text{SO}_4)_2 \cdot 6\text{H}_2\text{O}$ [MH] in a stoppered container. This may be labelled hydrated diammonium ferrous sulfate by some manufacturers.
<b>FA 2 [MH]</b>	120 cm <sup>3</sup>	0.01 mol dm <sup>-3</sup> potassium manganate(VII) in 0.5 mol dm <sup>-3</sup> H <sub>2</sub> SO <sub>4</sub>	See preparation instructions in the current syllabus.
<b>FA 3 [MH]</b>	80 cm <sup>3</sup>	1.0 mol dm <sup>-3</sup> sulfuric acid	See preparation instructions in the current syllabus.
<b>FA 5</b>	1.6 g	hydrated magnesium sulfate	Provide 1.5–1.7 g of MgSO <sub>4</sub> ·7H <sub>2</sub> O in a stoppered container.
<b>FA 6</b>	25 cm <sup>3</sup>	0.10 mol dm <sup>-3</sup> ammonium iron(III) sulfate in 0.10 mol dm <sup>-3</sup> sulfuric acid	Dissolve 48.2 g of $\text{NH}_4\text{Fe}(\text{SO}_4)_2 \cdot 12\text{H}_2\text{O}$ [MH] in each dm <sup>3</sup> of 0.10 mol dm <sup>-3</sup> H <sub>2</sub> SO <sub>4</sub> . To prepare 0.10 mol dm <sup>-3</sup> H <sub>2</sub> SO <sub>4</sub> dilute ten-fold 1.0 mol dm <sup>-3</sup> sulfuric acid [MH] (see preparation instructions in the current syllabus).
<b>FA 7</b>	10 cm <sup>3</sup>	0.10 mol dm <sup>-3</sup> sodium bromide	Dissolve 10.3 g of NaBr in each dm <sup>3</sup> of solution.
<b>FA 8</b>	10 cm <sup>3</sup>	0.50 mol dm <sup>-3</sup> sodium carbonate	Dissolve 53.0 g of Na <sub>2</sub> CO <sub>3</sub> [MH] or 143.1 g of Na <sub>2</sub> CO <sub>3</sub> ·10H <sub>2</sub> O [MH] in each dm <sup>3</sup> of solution.
<b>FA 9</b>	10 cm <sup>3</sup>	0.10 mol dm <sup>-3</sup> sodium chloride	Dissolve 5.85 g of NaCl in each dm <sup>3</sup> of solution.
<b>aqueous sodium sulfite [MH]</b>	5 cm <sup>3</sup>	0.10 mol dm <sup>-3</sup> sodium sulfite	Dissolve 12.6 g of Na <sub>2</sub> SO <sub>3</sub> [C][MH] in each dm <sup>3</sup> of solution. Prepare the solution as near to the examination as possible and keep in a stoppered bottle.
<b>aqueous potassium iodide</b>	5 cm <sup>3</sup>	0.10 mol dm <sup>-3</sup> potassium iodide	Dissolve 16.6 g of KI in each dm <sup>3</sup> of solution.
<b>starch solution</b>	5 cm <sup>3</sup>	freshly prepared aqueous starch solution (approx 2% solution w/v)	See preparation instructions in the current syllabus.
<b>distilled water</b>	200 cm <sup>3</sup>	distilled water	Supplied in a wash bottle.

- All solutions must be thoroughly mixed.
- If you are unable to source any of these chemicals, you must contact Cambridge International as far as possible in advance of the exam for advice.
- **Materials must be labelled only as specified in the 'label' column. The identities of chemicals labelled with letter codes, e.g. FA 1, may be different from their descriptions in the question paper. Candidates must use the descriptions given in the question paper.**
