**Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently, e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however, the use of the full mark range may be limited according to the quality of the candidate responses seen).

**GENERIC MARKING PRINCIPLE 6:**

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

**English & Media subject specific general marking principles**  
**(To be read in conjunction with the Generic Marking Principles (and requiring further guidance on how to place marks within levels))**

**Components using level descriptors:**

- We use level descriptors as a guide to broad understanding of the qualities normally expected of, or typical of, work in a level.
- Level descriptors are a means of general guidance and should not be interpreted as hurdle statements.
- Where indicative content notes are supplied for a question, these are *not* a prescription of required content, and must not be treated as such. Alternative correct points and unexpected answers in candidates' scripts must be given marks that fairly reflect the knowledge and skills demonstrated.
- While we may have legitimate expectations as to the ground most answers may occupy, we must at all times be prepared to meet candidates on their chosen ground, provided it is relevant ground (e.g. clearly related to and derived from a relevant passage/text and meeting the mark scheme requirements for the question).

**Components using point-based marking:**

Point marking is often used to reward knowledge, understanding and application of skills. We give credit where the candidate's answer shows relevant knowledge, understanding and application of skills in answering the question. We do not give credit where the answer shows confusion.

From this it follows that we:

- a** DO credit answers which are worded differently from the mark scheme if they clearly convey the same meaning (unless the mark scheme requires a specific term).
- b** DO credit alternative answers/examples which are not written in the mark scheme if they are correct.
- c** DO credit answers where candidates give more than one correct answer in one prompt/numbered/scaffolded space where extended writing is required rather than list-type answers. For example, questions that require *n* reasons (e.g. State two reasons ...).
- d** DO NOT credit answers simply for using a 'key term' unless that is all that is required. (Check for evidence it is understood and not used wrongly.).
- e** DO NOT credit answers which are obviously self-contradicting or trying to cover all possibilities.
- f** DO NOT give further credit for what is effectively repetition of a correct point already credited unless the language itself is being tested. This applies equally to 'mirror statements' (i.e. polluted/not polluted).
- g** DO NOT require spellings to be correct unless this is part of the test. However, spellings of syllabus terms must allow for clear and unambiguous separation from other syllabus terms with which they may be confused (e.g. Corrasion/Corrosion).

**Note:** All examiners are instructed that alternative correct answers and unexpected approaches in candidates' scripts must be given marks that fairly reflect the relevant knowledge and skills demonstrated. Nonetheless, the content must be clearly related to and derived from the texts.

2(c)	<p><b>Use <u>one</u> example from the text below to explain how the writer suggests other boats might be better suited to the planned journey.</b></p> <p><b><u>Use your own words in your explanation.</u></b></p> <p><b>My inflatable kayak would be the smallest boat to attempt this distance, an impertinent toy compared to the crafted cedar-log-dugout canoes paddled for centuries along these misty shores, or sturdy modern fibreglass canoes.</b></p> <p>Award 3 marks for an appropriate example with a comprehensive explanation which shows understanding of how the writer suggests how the writer suggests other boats might be better suited to the planned journey.</p> <p>Award 2 marks for an appropriate example and attempt at an explanation which shows some understanding of how the writer suggests how the writer suggests other boats might be better suited to the planned journey.</p> <p>Award 1 mark for an example with an attempt at an explanation which shows awareness of ways in which other boats might be better suited to the planned journey. The explanation may be partial.</p> <p>The explanation <b>must</b> be predominantly in the candidate's own words.</p> <p>Responses <b>might</b> use the following:</p> <ul style="list-style-type: none"> <li>• <b>smallest boat to attempt:</b> suggests the challenge of the distance; 'attempt' hints that success is unlikely and 'smallest' suggests it is more vulnerable than larger boats which may have attempted it previously / too tiny to cope with the journey</li> <li>• <b>impertinent toy:</b> suggests brash and irresponsible to try and 'toy' suggests only playing at it with a boat designed for children/leisure, not a professional responsible boater / kayaker</li> <li>• <b>crafted cedar-log-dugout canoes paddled for centuries:</b> suggests tried and trusted, long-lasting crafts that would afford protection; made with skill from natural, strong material in comparison to her inflatable plastic kayak; makes her boat seem faintly ridiculous / inferior in comparison</li> <li>• <b>sturdy modern fibreglass canoes:</b> suggests her boat is not sophisticated and perhaps has seen better times; comparison with professional boats made from better/stronger / high specification materials; hard and able to withstand impacts; less likely to be damaged</li> </ul>	3

Choose <u>three</u> examples of words or phrases from <u>each</u> paragraph to support your answer. Your choices should include the use of imagery.</b></p> <p><b>Write about 200 to 300 words.</b></p> <p><b><u>Up to 15 marks are available for the content of your answer.</u></b></p> <p>Use the Marking Criteria for Question 2(d) (Table A, Reading)</p> <p>Notes on task</p> <p>This question is marked for the ability to select powerful or unusual words and for an understanding of ways in which the language is effective. Expect responses to provide words / phrases that carry connotations additional to general meaning.</p> <p>Mark holistically for the overall quality of the response, not for the number of words chosen, bearing in mind that for the higher bands there should be a range of choices to demonstrate an understanding of how language works, and that this should include the ability to explain images. It is the quality of the analysis that attracts marks. Do not deduct marks for inaccurate statements; simply ignore them.</p> <p>The following notes are a guide to what good responses might say about the selections.</p> <p>Candidates can make any <i>sensible</i> comment, but only credit those that are relevant to the correct meanings of the words in the context and that have some validity. Alternative acceptable explanations should be credited. Credit comments on effects created by non-vocabulary choices such as grammar / syntax and punctuation devices. These must be additional to comments on vocabulary.</p> <p>[Only credit comments on stylistic effect where these are explicitly linked to choices.]</p>	15

2(d)	<p>Responses <b>might</b> use the following:</p> <ul style="list-style-type: none"> <li>• <b>Paragraph 4 begins ‘Looking at ...’ and is about the choice of route for the journey.</b></li> </ul> <p><i>Overview: naivety / romanticism / adventurous nature of decision to take a longer and more challenging route.</i></p> <ul style="list-style-type: none"> <li>• <b>paddle direct along established routes</b> (for fishing boats): suggests sensible option; less risky and used by others</li> <li>• <b>go ‘gunkholing’, as boaters say</b>: wants to appear to be / is a boater; is informed; part of the club, use of jargon to suggest expertise/ inside knowledge</li> <li>• <b>prowl</b> (in and out): moving like a predator searching; romanticised view of sleek and effective movement / adventurous exploration</li> <li>• <b>tiny coves</b>: small and hidden bays, sense of discovery</li> <li>• <b>meandering</b>: moving slowly, organically, like a body of water, may suggest getting older</li> <li>• <b>connecting a roundabout route</b>: creating own, original way of getting there via places of interest; not taking the shortest route, boats would not usually go this way</li> <li>• <b>trace excerpts of historic voyages</b>: follow back over parts of the routes of famous journeys, suggestion of brave sea tales / stories</li> <li>• <b>forage natural delicacies</b>: find food from surroundings, creature-like; suggests discoveries are rare and especially tasty / healthy and natural – being part of the wild / survival,</li> <li>• <b>communicate with ... endearing animals</b>: talk to wildlife encountered / connecting with nature; concentrating on cuter, less threatening animals – unrealistic and childish</li> <li>• <b>factoring in</b>: planning did not take account of the full range of possibilities, suggesting calculations should have included bears</li> </ul>

2(d)	<p>Responses <b>might</b> use the following:</p> <ul style="list-style-type: none"> <li>• <b>Paragraph 8 begins ‘He sneered ...’ and gives a description of the kayak.</b></li> </ul> <p><i>Overview: affectionate and amused description of the boat, recognising how others might view it.</i></p> <ul style="list-style-type: none"> <li>• <b>sneered:</b> looked with disdain, contemptuous, mocking / judgemental and dismissive of her hopes and ambitions</li> <li>• <b>limp, shapeless roll of plastic:</b> not yet rigid, undefined inelegant form, potentially ineffective / useless / lifeless and powerless</li> <li>• <b>newly-patched intrepid vessel:</b> has recently been repaired / suggestion that a leak might be likely as the boat sets off on its unlikely adventure / contradiction between ‘newly-patched’ and ‘intrepid’ reflects her optimism</li> <li>• <b>the plastic kayak squirmed slowly and reluctantly out of its wrinkles:</b> as it inflates it begins to extend to form a more recognisable shape, like a creature being teased out, not enthusiastic / embarrassed / awkward; wrinkles suggest age; not smooth / sleek</li> <li>• <b>gradually assumed a wonky banana shape:</b> slowly and with much effort started to inflate further to form a curve, though a bit lopsided; far from the sleek sea vessel expected / comic and silly image / like a toy or a child’s inflatable</li> <li>• <b>like a boat-shaped doughnut:</b> not actually a functioning boat, more like a cake made to resemble one and though amusing not up to the job; an indulgence; childish</li> <li>• <b>ridiculously optimistic red-and-white ‘racing stripes’:</b> clearly not capable of going fast enough to race any other boat, some embarrassment suggested / poking fun at herself</li> </ul>	<b>15</b>

<b>5</b>	<b>13–15</b>	<ul style="list-style-type: none"> <li>• Wide-ranging discussion of judiciously selected language with some high quality comments that add meaning and associations to words/phrases in both parts of the text, and demonstrate the writer's reasons for using them.</li> <li>• Tackles imagery with some precision and imagination.</li> <li>• There is clear evidence that the candidate understands how language works.</li> </ul>
