Students did not sit exam papers in the June 2020 series due to the Covid-19 global pandemic.

This mark scheme is published to support teachers and students and should be read together with the question paper. It shows the requirements of the exam. The answer column of the mark scheme shows the proposed basis on which Examiners would award marks for this exam. Where appropriate, this column also provides the most likely acceptable alternative responses expected from students. Examiners usually review the mark scheme after they have seen student responses and update the mark scheme if appropriate. In the June series, Examiners were unable to consider the acceptability of alternative responses, as there were no student responses to consider.

Mark schemes should usually be read together with the Principal Examiner Report for Teachers. However, because students did not sit exam papers, there is no Principal Examiner Report for Teachers for the June 2020 series.

Cambridge International will not enter into discussions about these mark schemes.

Cambridge International is publishing the mark schemes for the June 2020 series for most Cambridge IGCSE™ and Cambridge International A & AS Level components, and some Cambridge O Level components.

**Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

**GENERIC MARKING PRINCIPLE 6:**

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

**Note 1: All Examiners are instructed that alternative correct answers and unexpected approaches in candidates' scripts must be given marks that fairly reflect the relevant knowledge and skills demonstrated. Nonetheless, the content must be clearly related to and derived from the passage.**

2(c)	<p><b>Use <u>one</u> example from the text below to explain how the writer suggests his feelings about what he saw on the beach.</b></p> <p><b><u>Use your own words in your explanation.</u></b></p> <p><b>Initially, I was aware of only a few but, as I walked on, they grew in number, until the whole beach appeared to be covered with black lumps in a black carpet. Hundreds of oil-drenched penguins lay dead in the sand. Dead penguins, covered in thick, cloying, suffocating oil and tar. Each wave that broke piled another grim batch of carcasses on top of those already there. The sight was dreadful, sickening and depressing.</b></p> <p>Award 3 marks for an appropriate example with a comprehensive explanation which shows understanding of how the writer suggests his feelings</p> <p>Award 2 marks for an appropriate example and attempt at an explanation which shows some understanding of the birds' condition</p> <p>Award 1 mark for an example with an attempt at an explanation which shows awareness of meaning. The explanation may be partial.</p> <p>The explanation must be predominantly in the candidate's own words.</p> <p><b>Responses <i>might</i> use the following:</b></p> <ul style="list-style-type: none"> <li>• <b>they grew in number:</b> more and more seeming to arrive, nightmarish, hellish, as if surrounding him</li> <li>• <b>black lumps on a black carpet:</b> suggests lifeless and covering whole beach, sheer number emphasised, grotesque image of walking over / on the dead misshapen bodies</li> <li>• <b>dead (repetition at start of next sentence):</b> suggests shocked realisation, contrast with picture of penguins in the port</li> <li>• <b>thick, cloying, suffocating oil:</b> viscous substance, smothering the life out of the creatures, reminiscent of sound of oil as try to break away from it, nauseating, sickening</li> <li>• <b>piled another grim batch:</b> suggests treated with insensitivity of a production line, too many to count each, arriving in groups of dead birds on top of the last</li> <li>• <b>dreadful, sickening and depressing:</b> shocking, offensive sight, triplet emphasises overwhelming emotional impact of scene</li> </ul>	3

2(d)	<p><b>Re-read paragraphs 2 and 9.</b></p> <ul style="list-style-type: none"> <li>• <b>Paragraph 2 begins ‘Swimming in unison ...’ and is about the wildlife in the harbour.</b></li> <li>• <b>Paragraph 9 begins ‘Amid all this ...’ and is about approaching and capturing the bird.</b></li> </ul> <p><b>Explain how the writer uses language to convey meaning and to create effect in these paragraphs. Choose <u>three</u> examples of words or phrases from <u>each</u> paragraph to support your answer. Your choices should include the use of imagery.</b></p> <p><b>Write about 200 to 300 words.</b></p> <p><b><u>Up to 15 marks are available for the content of your answer.</u></b></p> <p>Use the Marking Criteria for <b>Question 2(d)</b> (Table A, Reading)</p> <p><b>Notes on task</b></p> <p>This question is marked for the ability to select powerful or unusual words and for an understanding of ways in which the language is effective. Expect responses to provide words / phrases (listed in the mark scheme on page 12) that carry connotations additional to general meaning.</p> <p>Mark holistically for the overall quality of the response, not for the number of words chosen, bearing in mind that for the higher bands there should be a range of choices to demonstrate an understanding of how language works, and that this should include the ability to explain images. It is the quality of the analysis that attracts marks. Do not deduct marks for inaccurate statements; simply ignore them.</p> <p>The following notes are a guide to what good responses might say about the selections.</p> <p>Candidates can make any <i>sensible</i> comment, but only credit those that are relevant to the correct meanings of the words in the context and that have some validity. Alternative acceptable explanations should be credited. Credit comments on effects created by non-vocabulary choices such as grammar / syntax and punctuation devices. These must be additional to comments on vocabulary.</p>	15

2(d)	<p>Responses <i>might</i> use the following:</p> <ul style="list-style-type: none"> <li> <p>wildlife in the harbour in paragraph 2, beginning ‘Swimming in unison ...’</p> <p><i>Overview: romanticised, even clichéd view of creatures in the harbor.</i></p> <p><b>swimming in unison:</b> perfectly synchronised, moving simultaneously as if performing</p> <p><b>shimmering shoals of sprats:</b> groups of fish glistening as sunlight catches them, suggests soft, attractive play of light</p> <p><b>raced around:</b> energetic, quick darting movements as if at play ( in reality they are trying to escape death)</p> <p><b>zigzagging, diving and reuniting:</b> movement from side to side and downwards and then back up again, as if playful rather than desperate</p> <p><b>scintillating waves of mesmerising light:</b> attractive, play of light on the fish/water, as if under its spell</p> <p><b>pulsed:</b> in waves, moved as if a life force / blood</p> <p><b>captivating:</b> charming, hypnotising</p> <p>(fly through the water) <b>twisting and turning:</b> ease of movement through the water, lithe, graceful and athletic</p> <p><b>snapping up:</b> continuous action of opening and closing beak to swallow fish, eating quickly and greedily with enthusiasm</p> <p><b>scattered:</b> dispersed, breaking up of the group, hint of desperation</p> </li> <li> <p>approaching and capturing the bird in paragraph 9, beginning ‘Amid all the obscenity ...’</p> <p><i>Overview: exaggerated danger and bravery of situation, humorous picture of ‘hero’ covered in rubbish facing the tiny but fierce creature.</i></p> <p><b>sparking with anger:</b> dangerous as if electrified, potentially fatal to touch</p> <p><b>eyeing me suspiciously:</b> as if capable of strategic thought, mistrusts intentions</p> <p><b>gladiator-like:</b> has a shield / spear (paper bag / stick) and net (fishing net from beach) fighter in ancient Rome, mock heroic</p> <p><b>quarry:</b> prey, hunting image</p> <p><b>malevolent:</b> evil creature, wishing him ill</p> <p><b>loathing and venom:</b> look of hatred and pure poison, reminiscent of vile creatures of myths and legends</p> <p><b>snapped shut with a savage metallic click:</b> single, abrupt, vicious, final action, sound suggests not flesh and bone but alien / robotic creation</p> <p><b>swiftness and bravery of Achilles:</b> mock heroic, not as strong as he sounds</p> <p><b>dropped. pushed. pinned. grabbed:</b> hurried sequence of events after initial cautious build up, little / no resistance from bird, anti-climax of one sided contest emphasises poor condition of bird</p> </li> </ul>

2(d)	<p>Only credit comments on stylistic effect where these are explicitly linked to choices.</p> <p><b>Reading Level 5 [13–15 marks]</b></p> <ul style="list-style-type: none"> <li>• Wide-ranging discussion of judiciously selected language with some high quality comments that add meaning and associations to words/phrases in both parts of the text, and demonstrate the writer’s reasons for using them.</li> <li>• Tackles imagery with some precision and imagination.</li> <li>• There is clear evidence that the candidate understands how language works.</li> </ul> <p><b>Reading Level 4 [10–12 marks]</b></p> <ul style="list-style-type: none"> <li>• Explanations are given of carefully selected words and phrases.</li> <li>• Explanations of meanings within the context of the text are secure and effects are identified in both parts of the text.</li> <li>• Images are recognised as such and the response goes some way to explaining them.</li> <li>• There is some evidence that the candidate understands how language works.</li> </ul> <p><b>Reading Level 3 [7–9 marks]</b></p> <ul style="list-style-type: none"> <li>• A satisfactory attempt is made to select appropriate words and phrases.</li> <li>• The response mostly gives meanings of words and any attempt to suggest and explain effects is basic or very general.</li> <li>• One half of the text may be better addressed than the other.</li> </ul> <p><b>Reading Level 2 [4–6 marks]</b></p> <ul style="list-style-type: none"> <li>• The response provides a mixture of appropriate choices and words that communicate less well.</li> <li>• The response may correctly identify linguistic devices but not explain why they are used.</li> <li>• Explanations may be few, general, slight or only partially effective.</li> <li>• They may repeat the language of the original or do not refer to specific words.</li> </ul> <p><b>Reading Level 1 [1–3 marks]</b></p> <ul style="list-style-type: none"> <li>• The choice of words is sparse or rarely relevant.</li> <li>• Any comments are inappropriate and the response is very thin.</li> </ul> <p><b>Reading Level 0 [0 marks]</b></p> <ul style="list-style-type: none"> <li>• The response does not relate to the question.</li> <li>• Inappropriate words and phrases are chosen or none are selected.</li> </ul>

Address each of the three bullets.</b></p> <p><b>Begin your article with a suitable headline.</b></p> <p><b>Write about 250 to 350 words.</b></p> <p><b><u>Up to 15 marks are available for the content of your answer and up to 10 marks for the quality of your writing.</u></b></p> <p>Use the Marking Criteria for <b>Question 3</b> (Table A, Reading and Table B Writing)</p> <p><b>Notes on task</b></p> <p>Candidates should select <b>ideas</b> from the text (see below) and <b>develop</b> them relevantly, supporting what they write with <b>details</b> from the text.
