**Generic Marking Principles**

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

**GENERIC MARKING PRINCIPLE 1:**

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

**GENERIC MARKING PRINCIPLE 2:**

Marks awarded are always **whole marks** (not half marks, or other fractions).

**GENERIC MARKING PRINCIPLE 3:**

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit is given for valid answers which go beyond the scope of the syllabus and mark scheme, referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

**GENERIC MARKING PRINCIPLE 4:**

Rules must be applied consistently e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

**GENERIC MARKING PRINCIPLE 5:**

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

**GENERIC MARKING PRINCIPLE 6:**

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

<b>Specific notes on the sequence – likely areas of coverage</b>			
<p><b>Camera:</b></p> <ul style="list-style-type: none"> <li>• framing low-angle shot</li> <li>• backlighting – creates mystery / in darkness</li> <li>• slow zoom into close up on Offred: her discomfort and conflict between formality and friendliness</li> </ul> <p><b>Sound:</b></p> <ul style="list-style-type: none"> <li>• voiceover</li> <li>• soundtrack in a minor key – unsettling and conservative</li> <li>• ominous foley of rain and thunder</li> </ul> <p><b>Editing:</b></p> <ul style="list-style-type: none"> <li>• secretive world through obstructive framing</li> <li>• sound bridge – being talked at</li> <li>• shot / reverse shot</li> <li>• slow pace building menacing atmosphere</li> <li>• eyeline-match</li> <li>• lingering shots and reaction shots</li> </ul> <p><b>Mise-en-scene:</b></p> <ul style="list-style-type: none"> <li>• costume – stylised so no eye contact can be made – repressive – uniform – like nuns (also suggested through diegetic tolling of bells)</li> <li>• muted repressed colours – and contrast with Mrs Waterford colours and costume</li> <li>• dystopian future- armed guard. Use of wartime rationing</li> </ul> <p><b>Meaning:</b></p> <p>Retro-future mise-en-scene – conservative values; defined antiquarian gender roles – 'return to traditional values'; culture of fear; religious overtones through dialogue and mise-en-scene; passive role of women – contrasting to the power of Commander Waterford.</p>

To what extent do you agree with this?</p>		<p>Candidates should be given credit for their knowledge and understanding, illustrated through case study material, relevant to the question. Assessment will take place across three criteria:</p> <ul style="list-style-type: none"> <li>• explanation / argument / analysis (20 marks)</li> <li>• use of supporting examples (20 marks)</li> <li>• use of terminology (10 marks)</li> </ul> <p>Candidates' work should be judged on each of these criteria individually and marks awarded according to the level attained. It should be noted that it is possible for a candidate to achieve a different level for each assessment criterion.</p>
